## TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “Release”) is made as of August 2, 2021, by Golub Capital LLC, in its capacity as administrative agent for the Secured Parties (“Agent”) in favor of Agilitas USA, Inc., an Illinois corporation, (“Agilitas”), Institute of Advanced Musculoskeletal Treatments LLC, a Delaware limited liability company (together with Agilitas, each a “Grantor” and together the “Grantors”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Guaranty and Security Agreement (as defined below).

### WITNESSETH:

WHEREAS, pursuant to the terms of that certain Guaranty and Security Agreement, dated as of April 21, 2017 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Guaranty and Security Agreement”), among the Grantors and the Agent, the Grantors were required to execute and deliver to Agent, for the benefit of the Secured Parties, the Trademark Security Agreement (as defined below);

WHEREAS, Agent and the Grantors were parties to that certain Trademark Security Agreement, dated as of April 21, 2017 (the “Trademark Security Agreement”), pursuant to which the Grantors granted, collaterally assigned and pledged to Agent, for the benefit of the Secured Parties, a continuing security interest in all of the Grantors’ right, title and interest in, to and under Trademark Collateral (as defined below), including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Trademark Security Agreement was recorded by the United States Patent and Trademark Office (“USPTO”) on April 21, 2017, at Reel 6039, Frame 0339; and

WHEREAS, Agent has agreed to release its security interest in and lien on all of the Grantors’ right, title and interest in, to and under the Trademark Collateral and reassign the same to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases, terminates and discharges its continuing security interest in the Grantors’ entire right, title and interest in and to the following, whether now owned or existing or hereafter created, acquired or arising (collectively, the “Trademark Collateral”):

(i) each Trademark listed on Schedule 1 annexed hereto, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each Trademark; and

(ii) all products and proceeds of the foregoing, including, without limitation, any claim by any Grantor against third parties for past, present or future (a) infringement or dilution of any Trademark, or (b) injury to the goodwill associated with any Trademark.

2. Agent hereby reassigns, grants and conveys to the Grantors, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest (if any) in and to the Trademark Collateral.
