## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release"), dated as of August 3, 2021 (the "Effective Date"), is made by CREDIT SUISSE AG, CAYMAN ISLANDS BRANCH, as Collateral Agent (in such capacity, the "Collateral Agent") in favor of EMERALD PERFORMANCE MATERIALS, LLC, a Delaware limited liability company, EMERALD KALAMA CHEMICAL, LLC, a Delaware limited liability company, EMERALD POLYMER ADDITIVES, LLC, a Delaware limited liability company (each, a "Grantor" and collectively, the "Grantors"). All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed to them in the Trademark Security Agreement (whether defined therein or by reference to another agreement).

WHEREAS, pursuant to that certain Security Agreement among the Grantors, the other Guarantors party thereto, and the Collateral Agent, dated as of August 12, 2020 (as may have been amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), the Grantors executed and delivered that certain Trademark Security Agreement, dated as of August 12, 2020 (the "Trademark Security Agreement"), which was recorded with the United States Patent and Trademark Office ("USPTO") on August 14, 2020 at Reel/Frame 7022/0192 (with respect to Emerald Performance Materials, LLC), at Reel/Frame 7022/0212 (with respect to Emerald Kalama Chemical, LLC), and at Reel/Frame 7022/0227 (with respect to Emerald Polymer Additives, LLC);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, each Grantor granted to the Collateral Agent and its successors a continuing security interest (the "Security Interest") in all of such Grantor's right, title and interest in, to and under the following, whether then owned or existing or thereafter acquired or arising (but excluding any Excluded Assets): (a) each United States Trademark constituting Recordable Intellectual Property owned by such Grantor, including, without limitation, each Trademark registration and application referred to in Schedule 1 hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each such Trademark; (b) each Trademark License constituting Recordable Intellectual Property to which the Grantor is a party, including, without limitation, each Trademark License identified in Schedule 1 hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each such Trademark licensed pursuant thereto; and (c) all Proceeds of and revenues from the foregoing; (collectively, the "Trademark Collateral"); and

WHEREAS, the Collateral Agent and the Grantors acknowledge that the requirements for releasing the Security Interest in the Trademark Collateral have been met.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby (a) terminates and cancels the Trademark Security Agreement, (b) releases, discharges, terminates and cancels the Security Interest in the Trademark Collateral, and (c) re-assigns to each Grantor any right, title or interest it may have in the Trademark Collateral of such Grantor, in each case without recourse to the Collateral Agent and without representation or warranty of any kind.

Each Grantor, or any successor to such Grantor (including any person or entity hereafter having any right, title or interest in or to the Trademark Collateral of such Grantor), is hereby authorized to record this Release in the USPTO.
