RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN PATENTS AND TRADEMARKS (this "Release") is made and effective as of July 31, 2021 (the "Effective Date") by U.S. BANK NATIONAL ASSOCIATION, its successors and/or assigns (the "Bank").

WITNESSETH:

WHEREAS, pursuant to a certain TRADEMARK SECURITY AGREEMENT dated December 6, 2018, and a certain PATENT SECURITY AGREEMENT dated December 6, 2018 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time) (collectively, the "Security Agreements"), by and between the Bank and COLBERT PACKAGING CORPORATION, an Illinois corporation ("Grantor"), Grantor granted to the Bank a security interest in certain patents, patent applications, trademarks, and trademark applications, as set forth in the Security Agreements, including without limitation that which is set forth on Schedule 1 of each respective Security Agreement (respectively the "Trademark Collateral" and the "Patent Collateral");

WHEREAS, the Grantor has requested that the Bank release its security interest in the Trademark Collateral and the Patent Collateral and reassign the same to the Grantor.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:


1. The Bank, without recourse, representation or warranty of any kind whatsoever, hereby terminates, cancels, releases, and discharges the security interest in the Trademark Collateral and the Patent Collateral created under the Security Agreements, including without limitation the patents and patent applications, and the trademarks and trademark applications listed on Schedule 1 of each respective Security Agreement.

2. The Bank agrees to take all further actions, and provide to Grantor and each of its successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by Grantor to more fully and effectively effectuate the purposes of this Release at the expense of the Grantor.
