ASSIGNMENT

WHEREAS **Willis North America Inc.**, a Delaware corporation with an address at 26 Century Boulevard, Suite 101, Nashville, TN 37214 (“the Assignor”), has used the mark **LAWYERGUARD** in connection with insurance underwriting in the field of professional liability insurance for lawyers (the “Mark”) and owns United States registration No. 4,812,934 of the Mark (the “Registration”); and


WHEREAS **Freberg Environmental, Inc.**, a Colorado corporation with an address at 1900 W. Littleton Boulevard, Littleton, Denver, CO 80120 (“the Assignee”), has acquired certain assets to which the Mark relates, with the intention of acquiring all right, title, and interest in and to the Mark and the Registration, together with the goodwill of the business symbolized by the Mark.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignor hereby:

1. Irrevocably transfers and assigns to Assignee, nunc pro tunc, effective as of April 30, 2020, all of Assignor’s right, title, and interest in and to the Registration, the Mark, and the goodwill of the business connected with the use of and symbolized by the Mark, including (i) all income, royalties, payments and other proceeds now or hereafter due or payable with respect thereto, and (ii) all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, in the case of each of the foregoing clauses (i) and (ii) to be held and enjoyed by Assignee for its own use and benefit and for its successors and assigns as the same would have been held by Assignor had this assignment not been made; and
2. Authorizes and requests the United States Patent and Trademark Office to record this assignment and Assignee as the owner of the Registration.

Any dispute arising under this Assignment shall be governed by and construed in accordance with the laws of the State of New York without regard to conflict of law principles.
