RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST (“**Release**”) is made and effective as of August 3, 2021, and granted by Compass Group Diversified Holdings LLC, a Delaware limited liability company (the “**Secured Party**”), in favor of Liberty Safe And Security Products, Inc., a Utah corporation (the “**Grantor**”), under that certain Intellectual Property Security Agreement, dated March 31, 2010 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “**IP Security Agreement**”), by the Grantor in favor of the Secured Party.

WHEREAS, pursuant to the IP Security Agreement, which was recorded with the United States Patent and Trademark Office at (a) Reel 4648, Frame 0737 on October 26, 2011, (b) Reel 4648, Frame 0297 on October 25, 2011, (c) Reel 027124, Frame 0835 on October 25, 2011, and (d) Reel 027119, Frame 0917 on October 25, 2011, the Grantor granted to the Collateral Agent, for the benefit of the secured parties, a security interest in and to all of the Grantor’s right, title and interest in, to and under the IP Collateral (as defined below);

WHEREAS, the Grantor has requested that the Collateral Agent enter into this Release in order to effectuate, evidence, and record the release and reassignment to the Grantor of any and all right, title and interest the Collateral Agent may have in the IP Collateral pursuant to the IP Security Agreement.

NOW, THEREFORE, in consideration of the premises and the agreements contained herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Release of Security Interest. Collateral Agent, on behalf of itself, its successors, legal representatives, and assigns, hereby terminates the IP Security Agreement and terminates, releases, and discharges any and all security interests that it has pursuant to the IP Security Agreement in any and all right, title and interest of the Grantor, and re-transfers, re-conveys, and re-assigns to the Grantor any and all right, title and interest that it may have, in, to and under the following (collectively, the “**IP Collateral**”):

(a) any and all patents, patent applications and other patent rights and any other governmental authority-issued indicia of invention ownership, including the patents and patent applications listed in Schedule 1 hereto, and all reissues, divisions, continuations, continuations-in-part, renewals, extensions, and reexaminations thereof and amendments thereto (the “**Patents**”);

(b) any and all trademarks, service marks, trade names, brand names, logos, trade dress, design rights, and other similar designations of source, whether registered or unregistered, including the trademark registrations and applications set forth in Schedule 2 hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof (“**Trademarks**”);

(c) all rights of any kind whatsoever of such Grantor accruing under any of the foregoing provided by applicable law of any jurisdiction, by international treaties and conventions and otherwise throughout the world;

(d) any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to any and all of the foregoing; and

(e) any and all claims and causes of action with respect to any of the foregoing, whether occurring before, on or after the date hereof, including all rights to and claims for damages, restitution and injunctive, and other legal and equitable relief for past, present and future infringement, dilution, misappropriation, violation, misuse, breach, or default, with the right but no obligation to sue for such legal and equitable relief and to collect, or otherwise recover, any such damages.

2. Further Assurances. Collateral Agent agrees to take all further actions, and provide to the Grantor and its successors, assigns and legal representatives all such cooperation and assistance, including, without limitation, the execution and delivery of any and all further documents or other instruments, as the Grantor and its/ successors, assigns, and legal representatives may reasonably request in order to confirm, effectuate or record this Release.

3. Governing Law. This Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Release and the transactions contemplated hereby shall be governed by, and construed in accordance with, the laws of the United States and the State of New York, without giving effect to any choice or conflict of law provision or rule (whether of the State of New York or any other jurisdiction).
