## TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS** (this “*Termination and Release*”) is granted as of August 2, 2021 by **CAMBRIDGE TRUST COMPANY** (the “*Lender*”), in favor of **EXENTA, INC.**, a Delaware corporation, (the “*Grantor*”).

**WHEREAS**, the Grantor executed and delivered a Trademark Security Agreement dated as of September 16, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”), granting the Lender a security interest in and lien on certain trademarks and trademark applications (“*Marks*”) described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on September 18, 2019, at Reel 006747, Frame 0699;

**WHEREAS**, the Grantor has requested that the Lender hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Marks as herein provided; and

**WHEREAS**, the Grantor has requested that the Lender provide a document suitable for recording with the USPTO to evidence the release of the Lender’s security interests in and liens on the Marks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under (i) the Marks, including without limitation those trademarks and trademark applications identified in Exhibit A hereto, (ii) all proceeds and products of the Marks, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same; and assigns, transfers and conveys to Grantor any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
