## TRADEMARK ASSIGNMENT

This Trademark Assignment (this "Assignment") is made and entered into as of July 15, 2021 ("Effective Date") by and between Concept Laboratories, an Illinois Corporation ("Assignor"), and CHAB LLC, an Illinois limited liability company ("Assignee").

WHEREAS, Assignor wishes to assign to Assignee, and Assignee wishes to acquire from Assignor, the United States trademark registration identified on Exhibit A, together with the goodwill of the business associated therewith (hereinafter referred to as the "Mark");

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00), and for other good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Assignor hereby sells, assigns, transfers and sets over to Assignee the entire right, title and interest in and to the Mark together with the goodwill of the business associated with the Mark and which are symbolized by the Mark, for the United States including, without limitation, any registrations and applications therefor, any renewals and extensions of the registrations, and all other corresponding rights that are or may be secured under the laws of the United States, now or hereafter in effect, for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made, together with all income, royalties or payments due or payable as of the Effective Date or thereafter, including, without limitation, all claims for damages by reason of past, present or future infringement or other unauthorized use of the Mark, with the right to sue for, and collect the same for Assignee's own use and enjoyment and for the use and enjoyment of its successors, assigns or other legal representatives.

2. Assignor requests the Commissioner of Patents and Trademarks, to record Assignee as the assignee and owner of the Mark.

3. At Assignee's sole cost and expense, Assignor shall take all further reasonable actions, and provide to Assignee, Assignee's successors, assigns or other legal representatives, all such reasonable cooperation and assistance (including, without limitation and to the extent applicable and available, the execution and delivery of any and all affidavits, declarations, oaths, samples, exhibits, specimens, assignments, powers of attorney or other documentation) reasonably requested by Assignee to more fully and effectively effectuate the purposes of this Assignment, including, without limitation, with respect to the following: (1) the preparation and prosecution by Assignee of any application for registration, or any application for renewal of a registration, relating to the Mark or rights assigned herein; (2) the prosecution or defense by Assignee of any interference, opposition, infringement or other proceedings that may arise in connection with the Mark


or rights assigned herein, including, without limitation, testifying as to any facts relating to the Mark and this Assignment; (3) obtaining any additional trademark protection relating to rights assigned herein that Assignee may deem appropriate that may be secured under the laws now or hereafter in effect in the United States; and (4) in the implementation or perfection of this Assignment in the United States of America.

4. This Assignment shall be governed by and construed in accordance with the laws of the State of Illinois or the laws of the United States of America, as applicable.
