**RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL (this "Release"), dated as of August 4, 2021, is made by Silicon Valley Bank, a California corporation, in its capacity as bank (the "Bank"), in favor of Giddy Inc., a Delaware corporation, Jubilant LLC, a Delaware limited liability company and Ashbrook Commerce Solutions LLC, a Delaware limited liability company (collectively, the "Grantors"), as follows:

WITNESSETH:

WHEREAS, pursuant to that certain Loan and Security Agreement, dated as of June 24, 2015 (as amended, supplemented or otherwise modified from time to time, collectively, the "Loan Agreement"), by and among, inter alios, the Grantors and the other parties party thereto, in favor of the Bank, and those certain agreements described on Annex I attached hereto (the "IP Security Agreements"), the Grantors granted a security interest in certain collateral in favor of the Bank, including the IP Collateral (as hereinafter defined); and

WHEREAS, the Bank now desires to terminate and release the IP Security Agreements and the entirety of its security interest in the IP Collateral, including without limitation the IP Collateral described on Annex II attached hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Bank hereby agrees as follows:

1. Definitions. The term "IP Collateral", as used herein, shall mean all of the Grantors' right, title or interest in, or to any and all of the Trademarks, Patents and Copyrights as defined in the IP Security Agreements (including without limitation the IP Collateral listed on Annex II attached hereto). Capitalized terms not defined herein have the meanings set forth in the IP Security Agreements, as applicable.

2. Release of Security Interest. The Bank, without recourse, representation or warranty, hereby terminates, cancels, releases, relinquishes, re-assigns and discharges, in its entirety, for the benefit of the Grantors, and their successors and assigns, its security interest in and to the IP Collateral (including without limitation the IP Collateral listed on Annex II attached hereto), the IP Security Agreements and any and all right, title and interest of the Bank in and to the IP Collateral and under the IP Security Agreements shall hereby be terminated, cancelled, released, relinquished, re-assigned and discharged. The Bank hereby authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office [and with the United States Copyright Office], to evidence and effectuate the release and termination of the Agent's security interest in the IP Collateral.



4. Governing Law. THIS RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HERETO SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
