Partial Release of Security Interest in Intellectual Property

THIS PARTIAL RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this “**Partial Release**”) is entered into as of July 29, 2021 by Barclays Bank PLC, as collateral agent (the “**Collateral Agent**” or the “**Assignee**”) for the lenders party to that Amended and Restated Term Loan Agreement, dated as of December 22, 2020 (as amended by that certain Amendment No. 1 to Amended and Restated Term Loan Agreement, dated as of January 29, 2021 and as amended, restated, amended and restated, supplemented or otherwise modified from time to time the “**Credit Agreement**”), among Kronos Acquisition Intermediate Inc., as Holdings, Kronos Acquisition Holdings Inc., as the Top Borrower (the “**Top Borrower**”), each other borrower party thereto, each lender from time to time party thereto, and the Collateral Agent, as the administrative agent.

WHEREAS, pursuant to the terms and conditions of that certain Term Loan Pledge and Security Agreement, dated as of August 26, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified immediately prior to the date hereof, the “**Security Agreement**”; all capitalized terms used but not defined herein shall have the respective meanings ascribed thereto in the Security Agreement or IP Security Agreement, as applicable), SolSkyn Personal Care LLC, Delaware limited liability company (the “**Assignor**”) granted to the Assignee a continuing security interest in and lien on all of its right, title and interest in and to the IP Collateral;

WHEREAS, reference is made to that certain Intellectual Property Security Agreement dated as of December 22, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified immediately prior to the date hereof, the “**IP Security Agreement**”), which granted to the Assignee for the benefit of the Secured Parties a continuing security interest in all of the right, title and interest of the Assignor (or the relevant predecessor in interest, as applicable) in and to the IP Collateral (as defined in the IP Security Agreement), including, without limitation, each Trademark registration and application referred to in Schedule A hereto;

WHEREAS, such IP Security Agreement was recorded with the Trademark division of the United States Patent and Trademark Office (“**USPTO**”) on December 22, 2020 in Reel 007143 Frame 0441;

WHEREAS, the Top Borrower has requested pursuant to Article 8 of the Credit Agreement and Section 7.12 of the Security Agreement that the Collateral Agent execute and deliver this Partial Release to evidence and acknowledge the termination and release of the security interest in and lien on the IP Collateral solely listed on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent agree as follows:

Section 1. Partial Release of Security Interest in IP Collateral. The Collateral Agent hereby terminates and releases and acknowledges the termination and release of, any and all security interests it has in or against the IP Collateral listed on Schedule A hereto. For the avoidance of doubt, this Partial Release does not terminate or release the Collateral Agent’s security interest in and lien on the IP Collateral not listed on Schedule A hereto.

Section 2. Recordation of Partial Release. The Collateral Agent hereby authorizes and requests that the USPTO record this Partial Release.


Section 3. Governing Law. This Partial Release shall be governed by and construed in accordance with the laws of the State of New York.
