**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, effective as of August 1, 2017 (“Release”), is made by Five Points Mezzanine Fund III, L.P., a Delaware partnership, as collateral agent (“Collateral Agent”) in favor of Workplace Options, LLC, a Delaware limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Security and Pledge Agreement dated as of April 24, 2017 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the “Security Agreement”) by and among the Grantor, Collateral Agent, and others party thereto, and the Notice of Grant of Security Interest in Intellectual Property dated as of April 24, 2017 by and among the Grantor and Collateral Agent (“Notice of Security Interest”), Grantor granted to the Agent, for the ratable benefit of the Lenders, a security interest in, all of Grantor' s right, title and interest in, to, and under all Trademark Collateral; and

WHEREAS, the Notice of Security Interest was recorded at the United States Patent and Trademark Office (“USPTO”) on April 25, 2017 at Reel 6041 Frame 0294.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Lenders and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice of Security Interest.

SECTION 2. Termination and Release. Collateral Agent, on behalf of the Lenders, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of Grantor's right, title and interest in, to, and under all the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule 1 attached hereto, granted pursuant to the Security Agreement or Notice of Security Interest; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.


SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of North Carolina.
