**TERMINATION AND RELEASE OF
SECURITY INTEREST IN
INTELLECTUAL PROPERTY**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Termination and Release"), dated as of August 6, 2021 is made by The Provident Bank, a Massachusetts Savings Bank (the "Lender").

WITNESSETH:

WHEREAS, pursuant to the Credit Agreement, dated as of December 31, 2018 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), between Wistia, Inc., a Delaware corporation with an address of 17 Tudor Street, Cambridge, MA 02139 (the "Borrower") and the Lender, with an address of 5 Market Street, Amesbury, MA 01913;

WHEREAS, pursuant to the IP Security Agreement, dated as of December 31, 2019 (the "IP Security Agreement"), a lien on and security interest (collectively, the "Security Interest") was granted by the Borrower to the Lender in certain collateral, including the Patents and Trademarks;

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office on January 9, 2019 at Reel/Frame 6516/0302.

WHEREAS, the Lender now desires to terminate and release the entirety of its Security Interest in the Patents and Trademarks, including those listed on Schedule 1 hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Lender hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein have the meanings set forth in the IP Security Agreement or the Credit Agreement, as applicable.
2. Release of Security Interest. The Lender hereby terminates, releases and discharges any and all Security Interest in the Patents and Trademarks (including those listed on Schedule 1 hereto), and any right, title or interest of the Lender in such Patents and Trademarks shall hereby cease and become void.
3. Recordation. The Lender authorizes the Borrower and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at the Borrower's expense.
