## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS dated as of August 3, 2021 (this “**Release**”), is made by CRG SERVICING LLC, a Delaware limited liability company, as administrative agent and collateral agent (in such capacities, together with its successors and assigns, “**Administrative Agent**”), in favor of HEALTHGRADES OPERATING COMPANY, INC. (formerly HEALTH GRADES, INC.; successor in interest to INFLUENCE HEALTH, INC.; and successor in interest to EVARIANT, INC.), a Delaware corporation (the “**Company**”).

**WHEREAS**, pursuant to that certain Security Agreement, dated as of December 30, 2019 (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), among the Company, other grantors from time to time party thereto, and the Administrative Agent, the Company pledged and granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest in all of the Company’s right, title and interest in, to and under all of its personal property, including without limitation the trademarks and trademark registrations and applications listed on **Schedule A** hereto;

**WHEREAS**, pursuant to the Security Agreement, the Company, as HEALTHGRADES OPERATING COMPANY, INC. (formerly HEALTH GRADES, INC.) executed and delivered to Administrative Agent, for the benefit of the Secured Parties, a Trademark Security Agreement, dated December 30, 2019 (the “**First Trademark Security Agreement**”);

**WHEREAS**, the First Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“**USPTO**”) on December 31, 2019, at Reel 006828, Frame 0858.

**WHEREAS**, pursuant to the Security Agreement, EVARIANT, INC., executed and delivered to Administrative Agent, for the benefit of the Secured Parties, a Trademark Security Agreement, dated December 30, 2019 (the “**Second Trademark Security Agreement**”);

**WHEREAS**, the Second Trademark Security Agreement was recorded at the USPTO on December 31, 2019, at Reel 006828, Frame 0873.

**WHEREAS**, EVARIANT, INC. transferred, assigned, delivered, and conveyed to HEALTHGRADES OPERATING COMPANY, INC. all right, title, and interest in and to certain transferred assets, including the trademarks subject to the Second Trademark Security Agreement, pursuant to an Asset Transfer Agreement dated February 1, 2020 (the “**ATA**”);

**WHEREAS**, the ATA was recorded at the USPTO on April 10, 2020, at Reel 006912, Frame 0784.

**WHEREAS**, pursuant to the Security Agreement, the Company, as HEALTHGRADES OPERATING COMPANY, INC. (successor in interest to INFLUENCE HEALTH, INC.), executed and delivered to Administrative Agent, for the benefit of the Secured Parties, a Trademark Security Agreement, dated March 3, 2020 (the “**Third Trademark Security Agreement**”);

**WHEREAS**, the Third Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“**USPTO**”) on March 3, 2020, at Reel 006880, Frame 0617.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby

acknowledged, and with the intention of being legally bound hereby, Administrative Agent, on behalf of the Secured Parties, and Company agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.

**SECTION 2. Termination and Release.** Administrative Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in all of the Company's right, title, goodwill, and interest in, to and under all of the trademarks, whether now owned or at any time hereafter acquired, of the Company that are registered with, or for which applications for registration have been filed with, the USPTO, including the trademarks listed on **Schedule A** hereto, and all registrations and pending applications associated therewith; and

(b) authorizes the recordation of this Release with the USPTO at Company's expense.



Choice of Law.** This Release and the rights and obligations of the parties hereunder shall be governed by, and construed in accordance with, the law of the State of New York, without regard to principles of conflicts of laws that would result in the application of the laws of any other jurisdiction; provided that Section 5-1401 of the New York General Obligations Law shall apply.
