**RELEASE OF SECURITY INTEREST  
(TRADEMARKS)**

THIS RELEASE OF SECURITY INTEREST (TRADEMARKS) (this "Release") is made effective as of August 3, 2021, by CIBC BANK USA, as Lender (the "Lender"), and HEALTHGRADES OPERATING COMPANY, INC. (formerly HEALTH GRADES, INC.), a Delaware corporation (the "Grantor").

WHEREAS, the Lender and Grantor entered into that certain Trademark Security Agreement, dated as of December 30, 2019 (the "Trademark Security Agreement"), whereby Grantor granted to the Lender a security interest in and to certain intellectual property of Grantor;

WHEREAS, the Trademark Security Agreement was recorded in the United States Patent and Trademark Office on December 30, 2019 at Reel 6827 and Frame 0698;

WHEREAS, in accordance with the provisions of the Trademark Security Agreement, the Lender now desires to release its security interest in and to the Collateral (as defined below).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby agrees as follows:

SECTION 1. Defined Terms. Each capitalized term used but not defined in this Release has the meaning given or ascribed to it in the Trademark Security Agreement.

SECTION 2. Release of Grant of Security. The Lender hereby (i) terminates the Trademark Security Agreement and (ii) terminates, releases and discharges its security interest in, and reassigns to Grantor, all right, title and interest in and to the following property (collectively, the "Collateral"):

- (a) all of Grantor's state (including common law) and federal and foreign trademarks, service marks and trade names, and applications for registration of such trademarks, service marks and trade names, all licenses relating to any of the foregoing and all income and royalties with respect to any licenses (including such marks, names, applications and registrations as described in Schedule A attached hereto), whether registered or unregistered and wherever registered, all rights to sue for past, present or future infringement or unconsented use thereof, all rights arising therefrom and pertaining thereto and all reissues, extensions and renewals thereof.

SECTION 3. Recordation. The Lender hereby authorizes Grantor or any of its authorized representatives to file this Release with the United States Patent and Trademark Office. The Lender hereby further authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

SECTION 4. Further Assurances. The Lender hereby agrees to execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably requested by Grantor, at Grantor's expense, to fully effectuate the purposes of this Release.

SECTION 5. Governing Law. This Release shall be governed by, and construed in accordance with, the laws of the State of New York, without regard to principles of conflicts of law, as the same may from time to time be in effect, including, without limitation, the UCC.
