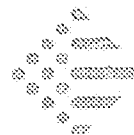

NOTARIAL TRANSCRIPT

THE UNDERSIGNED, FERNANDO MOLINA STRANZ, NOTARY PUBLIC OF THE ILLUSTRIOUS COLLEGE OF NOTARIES OF MADRID, A RESIDENT OF THIS CAPITAL CITY;

HEREBY CERTIFY THAT:

1.- On the 10th day of September, 2019, under Folio No. 1,334 of my protocol, I authorized the deed of **PARTIAL SPINOFF** of the company **"YELMO FILMS, S.L. Unipersonal"**, whose domicile is located at Pozuelo de Alarcón (Madrid), Paseo del Club Deportivo No. 1, Bloque 11, Planta Baja-Derecha, Suite D1, Parque Empresarial La Fina, with Taxpayer's ID No. (N.I.F.) B82721473 (the **"Company"**, **"Yelmo Films"** o the **"Spinoff Company"**), in favor of a recently created limited liability company known as **New Yelmo, S.L. Sociedad Unipersonal** (the **"Beneficiary Company"** or **"New Yelmo"**), which was organized by means of the deed specified above.

2.- As a consequence of the legalized partial spinoff under the deed referred to above (the "**Spinoff**"), Yelmo Films, as the spunoff company, transferred en masse and by universal succession, to New Yelmo, as beneficiary company, the Yelmo Films' branch in Florida (USA) known as Yelmo Films, S.L. Co. (the "**Branch**"), which is an autonomous and independent economic and organizational unit and, thus, the rights, obligations, assets, liabilities and legal relationships of all types included in the estate attributed to the Branch (the "**Spunoff Estate**"). Therefore, the Beneficiary Company has acquired universal succession and without solution of continuity or interruption in the activities, rights, obligations, assets, liabilities and legal relationships of all type included in the Spunoff Estate.

3.- In accordance with the provisions of Article 70.1 of the Structural Amendments Law, the Spunoff Company reduced its capital stock by **EIGHT MILLION FOUR HUNDRED AND SIXTY-EIGHT THOUSAND SEVEN HUNDRED AND EIGHT EUROS (€ 8,468,768.00)**, which was carried out by amortizing **THREE MILLION SEVENTY-NINE THOUSAND FIVE HUNDRED AND FIFTY-TWO (3,079,552)** partnership interests consecutively numbered from **18,670,111** to **21,749,662**, both inclusive, with a par value of **TWO EUROS 75/100 (€ 2.75)** each.

Therefore, after said reduction, the capital stock of the Spinoff Company amounts to FIFTY-ONE MILLION THREE HUNDRED AND FORTY-TWO THOUSAND EIGHT HUNDRED AND TWO EUROS 50/100 (€ 51,342,802.50), and is divided in EIGHTEEN MILLION SIX HUNDRED AND SEVENTY THOUSAND ONE HUNDRED AND TEN (18,670,110) partnership interests with a par value of TWO EUROS 75/00 (€ 2.75) each, consecutively numbered from 1 to 18,670,110, both inclusive, fully subscribed and paid up.

Additionally, the available reserves of the Spinoff Company (and, specifically, the accounting item known as "Merger reserves Yelmo Films - Carbondale 11-17-2016") was reduced in the amount of ELEVEN THOUSAND EIGHT HUNDRED AND SEVENTY-FIVE EUROS (€ 11,875.00).

4.- In view of the Spinoff, a limited liability company known as "New Yelmo, S.L. Sociedad Unipersonal" was organized, with a capital stock of THREE THOUSAND EUROS (€ 3,000.00) made up by THREE THOUSAND (3,000) equal, cumulative and indivisible partnership interests, with a par value of ONE EURO (€ 1.00) each and consecutively numbered from 1 to 3,000, both inclusive, and having a share premium amounting to EIGHT MILLION FOUR HUNDRED AND SEVENTY-SEVEN THOUSAND SIX HUNDRED AND FORTY-THREE EUROS (€ 8,477,643.00). The sum of the par value of the partnership interests created and the share premium is equal to the value of the Spinoff Estate.





5.- Likewise, on September 10, 2019, under number 1,336 of my protocol, I authorized the **DEED FOR THE MAINTENANCE OF NEW YELMO'S AFFILIATE**, whereby legalization is performed as to the resolutions passed by the Board of Directors of New Yelmo with regard to the maintenance of the Branch (acquired by universal succession as a consequence of the Spinoff) as a branch of New Yelmo in Miami, Florida (USA), which shall remain the owner of the assets and liabilities and, in general, of all legal relationships forming part of the Spinoff Estate, including, without limitation, all intellectual property rights, license and franchise agreements and know how, and shall operate under the name of New Yelmo, S.L. Co.

6.- The **PARTIAL SPINOFF DEED OF YELMO FILMS** (protocol number 1,334) was entered in the Registry of Commerce of Madrid on page M-261800 (open in the name of Yelmo Films), volume 37,185, folio number 31, Entry 56, and on page M-686423 (open in the name of New Yelmo), volume 38,598, folio number 118, Entry 1, dated October 6, 2019. Upon submission of said deed of spinoff in the Registry of Commerce on September 16, 2019, said date is considered as the date of entry of the Spinoff in accordance with Article 55 of the Regulations of the Registry of Commerce.

7.- The deed of **MAINTENANCE OF NEW YELMO'S BRANCH** (under protocol number 1,336) was entered in the Registry of Commerce of Madrid on page M-686423, folio number 126, Entry 3, dated October 7, 2019.
