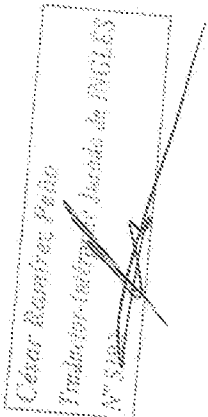

3.- It was further certified on that notarial instrument that, upon the Domestication becoming effective -i.e., upon registration of New Yelmo LLC with the Secretary of State of the State of Delaware (USA)- the branch of the Company in the State of Florida (USA) named "New Yelmo, S.L. Co." would be closed and terminated, whereby all the assets, liabilities and employees allocated to the branch would become assets, liabilities and employees of the domesticated company, i.e., New Yelmo LLC.

4.- The aforementioned notarial instrument has been registered with the Madrid Commercial Registry under volume 38,598, sheet 130, 8th section, at page M686423, together with the notarial instrument dated December 19, 2019 with no. 2063 of my public records. -----

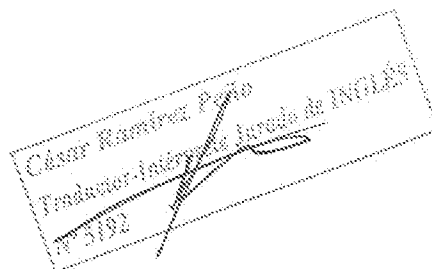
