PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **PARTIAL RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (“*Partial Release*”) is granted as of July 30, 2021 by **WILMINGTON TRUST, NATIONAL ASSOCIATION**, as administrative agent and collateral agent (the “*Grantee*”), in favor of **B&AND MATTER, LLC**, a Delaware limited liability company (the “*Grantor*”); and

WHEREAS, the Grantor, among others, has executed and delivered (i) a Grant of Security Interest in United States Trademarks, dated as of August 15, 2014 (the “*Agreement*”), which was recorded with the United States Patent and Trademark Office on August 15, 2014, at Reel 5345 and Frame 0172, (ii) a Grant of Security Interest in United States Trademarks, dated as of August 15, 2014, which was recorded with the United States Patent and Trademark Office on August 15, 2014, at Reel 5349 and Frame 0425, (iii) First Supplement to Grant of Security Interest in United States Trademarks, dated as of September 11, 2015, which was recorded with the United States Patent and Trademark Office on September 11, 2015, at Reel 5621 and Frame 0953 and (iv) Second Supplement to Grant of Security Interest in United States Trademarks, dated as of December 4, 2015, which was recorded with the United State Patent and Trademark Office on February 1, 2016, at Reel 5721 and Frame 0065 (each such agreement set forth in clauses (i), (ii) and (iii), collectively, the “*Trademark Agreements*”). All capitalized terms used but not defined herein shall have the meanings set forth in the Agreement; and

WHEREAS, the Grantor has requested that that the Grantee release and discharge fully its interest in the Marks set forth in Schedule A annexed hereto (the “*Specified Trademarks*”).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Grantee does hereby release and discharge fully any and all liens and security interests it may have in and to the Specified Trademarks expressly identified in Schedule A.

The Grantee hereby authorizes and requests that the United States Patent and Trademark Office note and record the present Partial Release of Security Interest in Trademarks.

Except for the release of Specified Trademarks specifically identified on Schedule A attached hereto, all terms and provisions of the Agreement shall remain in full force and effect. Nothing contained herein shall in any way impair the validity or enforceability of the Agreement, as modified hereby, or alter, waive, annul, vary, affect, or impair any provisions, conditions, or covenants contained therein or any rights, powers, or remedies granted therein. **Any lien and/or security interest granted in any Marks pursuant to the Agreement or the Security Agreement shall remain unchanged and in full force and effect except as specifically released hereby and shall continue to secure the payment and performance of all of the Secured Obligations (as defined in the Security Agreement).**

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS SHALL BE GOVERNED BY, AND CONSTRUED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK.
