***RELEASE OF SECURITY INTEREST IN TRADEMARKS***

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated August 6, 2021 by BMO Harris Bank N.A., a national banking association, with its mailing address at 111 West Monroe Street, Chicago, Illinois 60603 (“*BMO*”) acting as administrative agent (BMO acting as such administrative agent being hereinafter referred to as the “*Agent*”);

***WITNESSETH:***

WHEREAS, AmeriQual Group, LLC, an Indiana limited liability company (“*Debtor*”), with its mailing address at 18200 Highway 41 North, Evansville, Indiana 47725 and Agent were parties to a certain Trademark Collateral Agreement dated September 28, 2017 between Debtor and the Agent which was recorded in the United States Patent and Trademark Office on October 2, 2017 at Reel 6168, Frame 0336 (the “*Agreement*”), pursuant to which Debtor granted to Agent, a security interest in, among other things, each trademark, trademark registration and trademark application listed on Schedule A attached hereto and certain other property (collectively, the “*Trademark Property*”); and
