ASSIGNMENT OF RIGHTS AGREEMENT

THIS ASSIGNMENT OF RIGHTS AGREEMENT (this "Agreement"), is made and entered into as of the 10th day of August, 2021, by and between LAUREATE EDUCATION, INC., a Delaware public benefit corporation having its principal office at 650 South Exeter Street, Baltimore, MD 21202 ("Assignor"), and Walden University, LLC, a Florida limited liability company having its principal office at 7065 Samuel Morse Dr., Columbia, MD 21046 ("Assignee").

Reference is hereby made to that certain that Membership Interest Purchase Agreement, as may be amended from time to time, (the "MIPA"), dated as of September 11, 2020, by and between Assignor and Adtalem Global Education Inc., a Delaware corporation. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the MIPA.

WHEREAS, Assignor desires to assign to Assignee all of Assignor's right, title and interest in and to any and all Intellectual Property registrations and applications (i) for which Assignor or its Affiliates (other than the Company Group) are the owner of record at the applicable Governmental Authority and (ii) that are exclusively or primarily used or held for use in connection with the Business, including the registrations and applications set forth on Attachment A hereto (the "Assets"); and

WHEREAS, Assignee desires to accept such assignment;

NOW THEREFORE, for \$10.00 and other good and valuable consideration, the receipt of which is hereby mutually acknowledged, the parties hereto, intending to be legally bound, hereby agree as follows:

Article 1

TRANSFER AND ASSIGNMENT

1.1 Conveyance of Rights. Assignor hereby transfers, grants, conveys, assigns and relinquishes exclusively to Assignee all of Assignor's right, title, and interest in and to the Assets, in perpetuity (or for the longest period of time otherwise permitted by law), including the following properties.

1.1.1 All right, title, interest, and benefit (including, under the patent laws, to make, use, offer to sell, sell, or import; under the copyright laws, to reproduce, prepare derivative works, modifications or variations of, distribute, perform, or display; and, under trade secret laws, to use or disclose) of Assignor in and to all United States and foreign patents and patent applications, patent license rights, patentable inventions, trade secrets, trademarks, service marks, trade names (including, in the case of trademarks, service marks and trade names, the goodwill of the business symbolized by said marks and names, the right of Assignor to conduct business under said marks and names, and the right to sue and to collect damages for past infringements of said patents, marks and names), and all other intellectual property rights owned or claimed by Assignor embodied in the Assets.

- 1.1.2 All right, title, interest, and benefit of Assignor to any past, present or future claims or causes of action regarding the infringement of or other matters relating to the Assets.
 - 1.1.3 All right, title, interest, and benefit of Assignor to any existing licenses or related to the Assets, and to all income, royalties, damages, claims, and payments now or hereafter due or payable with respect to the Assets, and in and to all causes of action, either in law or in equity, for past, present, or future infringement based on the Assets, and in and to all rights corresponding to the foregoing throughout the world.
 - 1.2 Further Assurances. Assignor shall execute and deliver, at Assignor's sole expense, conveyance instruments, and take further actions, as may be necessary or desirable to evidence the transfer of ownership of all Assets to Assignee, or the original ownership of all the Assets on the part of Assignee, to the fullest extent possible. Assignor therefore agrees to:
 - 1.2.1 Execute, acknowledge, and deliver any affidavits or documents of assignment and conveyance regarding the Assets, to the applicable Governmental Authority, third party or Assignee, as directed by Assignee;
 - 1.2.2 Provide testimony and documentation (as may be requested by Assignee) in connection with any suits or proceedings affecting the right, title, interest, or benefit of Assignee and to the Assets;
 - 1.2.3 Provide testimony and documentation (as may be requested by Assignee) in connection with any suits or proceedings brought by Assignee to enforce or defend Assignee's rights in the Assets; and
 - 1.2.4 Perform any other acts deemed necessary to carry out the intent of this Agreement.
 - 1.3 Acknowledgment of Rights. In furtherance of this Agreement, Assignor hereby acknowledges that, from this date forward, Assignee has succeeded to all of Assignor's right, title, and standing to:
 - 1.3.1 Receive all rights and benefits pertaining to the Assets;
 - 1.3.2 Institute and prosecute all suits and proceedings and take all actions that Assignee, in its sole discretion and at its expense, may deem necessary or proper to collect, assert, or enforce any claim, right, or title of any kind in and to any and all of the Assets, past, present and future; and

- 1.3.3 Defend and compromise any and all such actions, suits, or proceedings relating to such transferred and assigned rights, title, interest, and benefits, and do all other such acts and things in relation thereto as Assignee, in its sole discretion and at its sole expense, deems advisable.
- 1.4 With respect to copyrights assigned under this Agreement, Assignor hereby irrevocably waives in favor of Assignee, to the extent permitted by applicable law, any and all claims Assignor may now or hereafter have in any jurisdiction to all rights of paternity or attribution, integrity, disclosure, and withdrawal and any other rights that may be known as “moral rights” in relation to all works of authorship to which the assigned copyrights apply.
- 1.5 Power of Attorney. To effectuate the terms of this Article 1, and without limiting Assignor’s obligations under the MIPA (including, for clarity, Section 5.07 therein), Assignor hereby names and irrevocably constitutes and appoints Assignee, with the full power of substitution therein, as Assignor’s rule and lawful attorney-in-fact to exercise the rights assigned hereby.

Article 2

REPRESENTATIONS AND WARRANTIES

- 2.1 Assignor and Assignee agree that (i) any and all representations and warranties relating to the Assets are set forth in the MIPA, and no additional representations or warranties, express or implied, are given in this Agreement, and (ii) Assignor’s obligations in Section 1.2 and Section 1.5 herein shall not exceed the obligations outlined in Section 5.07 of the MIPA or such other obligations related to the Pre-Closing IP Transfer set forth in the MIPA.

Article 3

MISCELLANEOUS

- 3.1 This Agreement shall inure to the benefit of, and be binding upon, the parties hereto together with their respective legal representatives, successors, and assigns.
- 3.2 This Agreement shall be governed by, and construed in accordance with, Maryland law.
- 3.3 This Agreement, subject to and without limiting any other Ancillary Documents and the MIPA, merges and supersedes all prior and contemporaneous agreements, assurances, representations, and communications between or among the parties hereto concerning the matters set forth herein.




