Assignor will promptly do and perform, or cause to be done and performed, any further acts and things, and will execute and deliver all other agreements, certificates, instruments, and documents as Assignee may request in order to carry out the intent and accomplish the purpose of this Assignment and confirm, perfect, or record the rights transferred hereby.
