RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT is dated August 11, 2021, by JPMorgan Chase Bank, N.A., in its capacity as administrative agent for the lenders (“*Administrative Agent*”).

WITNESSETH:

WHEREAS, Administrative Agent and Ice Services LLC (“*Grantor*”), are parties to a certain Trademark Security Agreement dated as of April 3, 2019 (“*Trademark Security Agreement*”), which was recorded in the United States Patent and Trademark Office on April 4, 2019, at Reel 6609, Frame 0103, pursuant to which the Grantor granted a security interest in and collateral assignment of certain trademarks, trademark registrations and trademark applications listed on Schedule A attached hereto and certain other property (collectively, the “*Trademarks*”); and

WHEREAS, the Grantor has requested that the Administrative Agent release its security interests in the Trademarks and reassign the same to the Grantor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

The Administrative Agent hereby releases its security interests in, and reassigns, grants and conveys to the Grantor, without any representation, warranty, recourse or undertaking by the Administrative Agent, all of its right, title and interest, if any, in and to the Trademark Collateral, as defined in the Trademark Security Agreement, including, inter alia:


(i) Each of the Trademarks, together with any reissues, continuations or extensions thereof, and all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark; and

(ii) All proceeds of the foregoing, including without limitation any claim by Grantor against third parties for damages by reason of past, present or future (i) infringement or dilution of each such Trademark, or (ii) injury to the goodwill associated with each such Trademark.
