## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks is made as of February 28, 2014, by U.S. BANK NATIONAL ASSOCIATION, a national banking association (the "Secured Party"), for itself and as administrative agent for the Lenders (as defined in the Credit Agreement referenced below).

WHEREAS, ProSchools Acquisition Company, a corporation organized under the laws of the State of Delaware ("PSAC"), ProSchools, Inc., a corporation organized under the laws of the State of Oregon ("PSI"), Compliance Management Services, LLC, a limited liability company organized under the laws of the State of Maryland ("CMS"), Keen Skills, Inc., a corporation organized under the laws of the State of Florida ("KSI"), American Home Inspectors Training Institute, Ltd., a corporation organized under the laws of the State of Wisconsin ("AHITI"), Advanced Education Systems, LLC, a limited liability company organized under the laws of the State of Maryland ("AES"), Digital University, Inc., a California corporation ("DU" and collectively with PSAC, PSI, CMS, KSI, AHITI and AES, each a "Borrower" and collectively, the "Borrowers"), the Secured Party, and the Lenders have entered into a Credit Agreement dated September 7, 2012 (as amended, supplemented, extended, restated or otherwise modified from time to time, the "Credit Agreement") pursuant to which the Lenders have agreed, among other things, to extend to the Borrowers certain credit accommodations;

WHEREAS, Corporate Training Technologies LLC, a Delaware limited liability company ("CTT") has guaranteed the obligations of the Borrowers under the Credit Agreement;

WHEREAS, in connection with the Credit Agreement, (i) PSI entered into that certain Confirmatory Grant of Security Interest in Intellectual Property, dated as of September 7, 2012 (the "PSI Grant"), pursuant to which PSI granted a security interest to the Secured Party for the benefit of the Lenders in the trademarks listed on Schedule A-1 attached hereto, which PSI Grant was recorded on September 11, 2012 in the U.S. Patent and Trademark Office (the "USPTO") at Reel 4858, Frame 0617 (the "PSI Trademarks"), (ii) KSI entered into that certain Confirmatory Grant of Security Interest in Intellectual Property, dated as of September 7, 2012 (the "KSI Grant"), pursuant to which KSI granted a security interest to the Secured Party for the benefit of the Lenders in the trademarks listed on Schedule A-2 attached hereto, which KSI Grant was recorded on September 11, 2012 in the USPTO at Reel 4858, Frame 0523 (the "KSI Trademarks"), (iii) AES entered into that certain Confirmatory Grant of Security Interest in Intellectual Property, dated as of September 7, 2012 (the "AES Grant"), pursuant to which AES granted a security interest to the Secured Party for the benefit of the Lenders in the trademarks listed on Schedule A-3 attached hereto, which AES Grant was recorded on September 11, 2012 in the USPTO at Reel 4858, Frame 0535 (the "AES Trademarks"), and (iv) CTT entered into that certain Confirmatory Grant of Security Interest in Trademarks, dated as of September 4, 2013 (the "CTT Grant" and, collectively with the PSI Grant, the KSI Grant and the AES Grant, the "Grants"), pursuant to which CTT granted a security interest to the Secured Party for the benefit of the Lenders in the trademarks listed on Schedule A-4 attached hereto, which CTT Grant was recorded on September 5, 2013 in the USPTO at Reel 5106, Frame 0048 (the "CTT Trademarks" and, collectively, with the PSI Trademarks, the KSI Trademarks and AES Trademarks, the "Trademarks"); and


WHEREAS, the Secured Party has agreed to release its security interest in and to the Trademarks;
