**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of August 11, 2021 (this "Release"), is made by OWL ROCK CAPITAL CORPORATION, in its capacity as collateral agent for the Secured Parties (in such capacity, the "Collateral Agent"), in favor of NUTRAMARKS, INC., a Delaware corporation (the "Grantor"). Capitalized terms used but not otherwise defined herein have the meaning given to them in the Security Agreement.

**WITNESSETH**

WHEREAS, Grantor and the Collateral Agent are parties to that certain Security Agreement, dated as of September 30, 2020 (as amended, restated, amended and restated, replaced, supplemented or otherwise modified, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Grantor executed the Trademark Security Agreement, dated as of September 30, 2020 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office on September 30, 2020 at Reel/Frame No. 7065/0247, pursuant to which the Grantor pledged and granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in and to all of its right, title and interest in, to and under the Trademark Collateral (as defined in the Trademark Security Agreement).

WHEREAS, the Grantor has requested that the Collateral Agent release its security interest in all right, title and interest in, to and under the Trademark Collateral set forth in Schedule I attached hereto.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in such Trademark Collateral set forth in Schedule I attached hereto is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral set forth in Schedule I attached hereto under the Security Agreement and the Trademark Security Agreement.
