## TRADEMARK ASSIGNMENT AGREEMENT

**THIS TRADEMARK ASSIGNMENT AGREEMENT** (“Assignment”), effective as of the date below (“Effective Date”), is by and between **Chan Zuckerberg Initiative, LLC**, a Delaware limited liability company with its principal place of business at 2682 Middlefield Road, Suite i, Redwood City, California 94063 (“Assignor”), and **The Just Trust for Action**, a North Carolina non-profit corporation with its principal place of business at 2530 Meridian Parkway, Suite 300, Durham, North Carolina 27713 (“Assignee”), each of Assignor and Assignee a “Party,” and collectively, the “Parties.”

**WHEREAS**, Assignor wishes to hereby assign to Assignee, and Assignee wishes to acquire from Assignor, any and all right, title and interest that Assignor owns in the application Serial No. 90770211 for the trademark THE JUST TRUST (the “Application”), and all common-law rights associated therewith and all goodwill associated therewith and symbolized thereby;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:



Assignor hereby irrevocably and unconditionally assigns, all of Assignor’s worldwide right, title, and interest in and to the Application, together with the goodwill symbolized by the mark in the Application, to Assignee as successor of the business to which the mark relates. Assignor further irrevocably and unconditionally assigns to Assignee the right to bring all claims in Assignee’s own name for past, present, and future infringement, misappropriation, or other violation of the mark issuing from the Application, on a world-wide basis, including all rights to sue for and to receive and recover all profits and damages accruing from any infringement, misappropriation, dilution, or other injury or violation as well as the right to grant releases for past, present and future infringements, dilution, or other injury to the goodwill thereof.
2. Assignor hereby requests the United States Patent and Trademark Office to record Assignee as the assignee and owner of the Application.
3. Assignor hereby agrees to execute all such documents as may be required to transfer and, when applicable, to record the transfer of the Application and any trademark registration issuing from the Application.
