DEED OF ASSIGNMENT OF TRADEMARKS

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby assign and transfer to Assignee, its successors and assigns, all of Assignor's right, title, and interest in and to the Trademarks, together with the goodwill connected with the use of and symbolized by the Trademarks, and the right to sue and recover for, and the right to profits or damages due or accrued, arising out of or in connection with any and all past, present, or future infringements or dilution of or damage to the Trademarks or the associated goodwill.

Assignor further agrees that, without further consideration, it will cause to be performed such other lawful acts, and to be executed such further assignments and other lawful documents, as Assignee may, from time to time, reasonably request to effect fully this Assignment and to permit Assignee to be duly recorded as the registered owner of the Trademarks in the United States. Assignee shall be responsible for all fees for recordation of this Assignment, and Assignor agrees to cooperate fully with Assignee to accomplish such recordation.

THIS TRADEMARK ASSIGNMENT AGREEMENT shall be binding upon and shall inure to the benefit of Assignor and Assignee and their respective successors and assigns.
