RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of August 10, 2021 by COMERICA BANK (“Bank”), in favor of BLOOMFIRE, INC., a Delaware corporation (“Company”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Intellectual Property Security Agreement (as defined below).

WHEREAS, the Company entered into a certain security agreement dated February 3, 2015 (the “Intellectual Property Security Agreement”) with Bank, notice of which was recorded on February 4, 2015 at the United States Patent and Trademark Office at Reel 5452, Frame 0710.

WHEREAS, Company granted the Bank, under the terms of the Intellectual Property Security Agreement, a continuing security interest in favor of the Bank, in all of its right, title and interest in and to the Intellectual Property Collateral, including the trademarks listed on Schedule I attached hereto and made a part hereof.

WHEREAS, the Bank has agreed to terminate and release its security interest in all such Intellectual Property Collateral as herein provided.



Bank consents and agrees to execute and deliver, at the request and cost of Company, such further instruments, documents and release forms as Company may reasonably request to more effectively, release, terminate and extinguish any such liens and security interests upon such trademarks.


