**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of August 13, 2021 by **LATERAL SMA AGENT, LLC**, as Agent (the “*Agent*”), in favor of **MORAE GLOBAL CORPORATION** and **CLUTCH GROUP LLC** (each, individually, a “*Grantor*” and collectively the “*Grantors*”).

WHEREAS, Grantors executed and delivered a Trademark Security Agreement dated as of April 30, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”) granting the Agent a security interest in and lien on certain trademarks and trademark applications (“*Trademarks*”) described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on May 2, 2019, at Reel 6633, Frame 0661;

WHEREAS, Grantors have requested that Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of each Grantor in, to and under all of the Trademarks as herein provided; and

WHEREAS, Grantors have requested that the Agent provide a document suitable for recording with the USPTO to evidence the release of the Agent’s security interests in and liens on the certain Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby:

1. terminates the Grant and releases, terminates and discharges, without representation, recourse or warranty whatsoever, all of its liens and security interests in the Grantors’ right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those certain Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded, at the Grantors’ expense, at the USPTO.

THIS TERMINATION AND RELEASE AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES HEREUNDER SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE INTERNAL LAWS (AND NOT THE CONFLICT OF LAW RULES) OF THE STATE OF NEW YORK.
