## TRADE-MARK ASSIGNMENT AGREEMENT

The assignment shall be binding upon the Assignor, its successors and/or assigns, and all others acting by, through, with or under its direction, and all those in privity therewith.

The Assignor hereby authorizes the Commissioner of Trademarks to transfer all registrations and applications for the Trade-Marks to Assignee as Assignee may direct, in accordance with this Trademark Assignment, and to issue to Assignee all registrations which may issue with respect to any pending applications.

The Assignee hereby appoints Powley & Gibson, P.C. whose full postal address is 304 Hudson Street, Suite 202, New York, NY 10013, as the firm to which any notice in respect of the Trade-Marks may be sent and upon whom service of any proceeding in respect of same may be given or served with the same effect as if they had been given to or served upon the owner itself.
