The ASSIGNOR additionally agrees to execute copies of this assignment or portions thereof regarding any or all of the aforementioned MARKS, as required by the ASSIGNEE in the future.

3. The ASSIGNOR of the MARKS hereby agrees to waive all rights and privileges to attack any of the MARKS or the registration of any or all of the MARKS.

4. The ASSIGNOR makes no representations or warranties in this document regarding title to the MARKS.
