

Pursuant to the provisions of Section 1003 of the New York Limited Liability Company Law (the "NY LLCL"), the undersigned, Crowley Chemical Company, Inc., a New York corporation ("CCC"), and CrowChem, LLC, a New York limited liability company ("CrowChem"), hereby certify the following information relating to the merger of CCC with and into CrowChem (the "Merger"):

**FIRST:** The name and state of formation of each of the constituent companies of the Merger (the "Constituent Companies") are as follows:

**SECOND:** CCC filed its initial certificate of incorporation on October 26, 1976.

CrowChem filed its initial articles of organization on August 23, 2018.

**THIRD:** The surviving domestic limited liability company is CrowChem, LLC (the "Surviving Company").

**FOURTH:** The Agreement and Plan of Merger, dated as of August 31, 2018 (the "Merger Agreement"), by and between CCC and CrowChem, setting forth the terms and conditions of the Merger, has been adopted, approved and executed by CCC and the Surviving Company in accordance with each of its constituent documents and the applicable provisions of the NY LLCL.

**FIFTH:** The articles of organization of the Surviving Company, as in effect immediately prior to the effective date of the Merger, shall be amended to change the name of the Surviving Company to Crowley Chemical Company, LLC.

- SIXTH:** The effective date of the Merger, in accordance with Section 1003(b) of the NY LLCL, is August 31, 2018.
- SEVENTH:** The Secretary of State of the State of New York (the "Secretary of State") is designated as the Surviving Company's agent upon whom process against it may be served. 




