RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of August 12, 2021, by BANK OF AMERICA, N.A., as administrative agent and collateral agent for the Secured Parties (in such capacity, together with its successors and permitted assigns, the “**Collateral Agent**”), in favor of RING CONTAINER TECHNOLOGIES, LLC (the “**Grantor**”). Capitalized terms used but not defined herein have the meanings specified (including by reference) in the Security Agreement (as defined below).

WHEREAS, the Grantor and the Collateral Agent are party to (i) that certain First Lien Pledge and Security Agreement dated as of October 31, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “**Security Agreement**”), (ii) that certain First Lien Trademark Security Agreement, dated as of October 31, 2017 (the “**Trademark Security Agreement**”) and (iii) that certain First Lien Trademark Security Agreement Supplement, dated as of August 13, 2019 (the “**Trademark Security Agreement Supplement**”) whereby the Grantor granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in all of the Grantor’s right, title and interest in, to and under the Trademark Collateral and the Additional Trademark Collateral (as defined in the Trademark Security Agreement and the Trademark Security Agreement Supplement, respectively), including those United States Trademarks listed on Schedule I attached hereto;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on December 1, 2017 at Reel/Frame 6194/0459;

WHEREAS, the Trademark Security Agreement Supplement was recorded with the United States Patent and Trademark Office on August 16, 2019 at Reel/Frame 6720/0279; and


WHEREAS, the Grantor has requested that the Collateral Agent execute and deliver this Release to evidence the release of its security interest in the Trademark Collateral and the Additional Trademark Collateral for filing and recordation with the United States Patent and Trademark Office.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent, without any representation, warranty or recourse of any kind or nature, hereby releases and terminates its security interest in the Trademark Collateral and the Additional Trademark Collateral, and re-assigns and re-conveys to the Grantor any and all right, title or interest the Collateral Agent may have in, to or under, the Trademark Collateral and the Additional Trademark Collateral.
