

## RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated June 30, 2021 by Pinnacle Bank, a Tennessee Bank, with its mailing address at 128 Franklin Road, Brentwood, TN 37027 (“*Lender*”);

### WITNESSETH:
