**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 16, 2021 ("Release"), is made by BSP Agency, LLC, a Delaware limited liability company (as successor agent to Business Development Corporation of America, as Administrative Agent ("Prior Agent") pursuant to the Successor Agent Agreement dated as March 1, 2018 ("Successor Agent Agreement"), the "Successor Agent") in favor of Centiv Services Corp., a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain Second Lien Security Agreement dated as of December 1, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among the Grantor, Prior Agent, and others party thereto, and the Trademark Security Agreement dated as of December 1, 2015 by and among the Grantor and Prior Agent ("Trademark Security Agreement"), Grantor granted to Prior Agent, for the benefit of the Secured Parties, a continuing security interest in, lien and mortgage in and to, right of setoff against and collateral assignment of all of such Grantor's right, title and interest in and to all Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on August 22, 2016 at Reel 5860 Frame 0648;

WHEREAS, pursuant to the Successor Agent Agreement and the Notice of Succession of Agency (Intellectual Property) dated as of March 1, 2018 ("IP Notice") each by and among the Prior Agent and Successor Agent, the Prior Agent resigned as, and Successor Agent was appointed and accepted appointment as, the Administrative Agent, and the security interest granted to the Prior Agent pursuant to the Security Agreement and Trademark Security Agreement was succeeded by and transferred to the Successor Agent; and

WHEREAS, the IP Notice was recorded at the USPTO on May 11, 2018 at Reel 6330 Frame 0869.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Successor Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement, Trademark Security Agreement, or IP Notice.

SECTION 2. Termination and Release. Successor Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, lien and mortgage in and to, right of setoff against and collateral assignment of all of such Grantor's right, title and interest in and to all Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement, Trademark Security Agreement, or IP Notice; and

(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.


SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
