SUPPLEMENT NO. 1 TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Supplement No.1 to Intellectual Property Security Agreement (this “**Supplement**”) is made as of the 17th day of August, 2021, by **NISOS HOLDINGS, INC.**, a Delaware corporation (“**Grantor**”), in favor of **WESTERN ALLIANCE BANK**, an Arizona corporation (“**Lender**”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of February 19, 2021 (as amended and of record from time to time hereinafter, the “**Agreement**”) in favor of the Lender, pursuant to which the Grantor granted a security interest in certain Intellectual Property Collateral (as defined therein), which was recorded on February 22, 2021 at Reel 7199 Frame 0363 in the Trademark division of the U.S. Patent and Trademark Office.

WHEREAS the Grantor desires to confirm the grant of a security interests in certain additional Intellectual Property Collateral in favor of the Lender.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.
2. Supplement to Trademark Exhibit B. Exhibit B to the Grant is hereby supplemented, but not replaced, by Trademark Exhibit B-1 annexed hereto.
3. Miscellaneous:
 - a. Except as provided herein, all terms and conditions of the Grant remain in full force and effect.
 - b. This Supplement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
