**CONFIRMATORY TERMINATION OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENTS**

**August 17, 2021**

WHEREAS, AccuVein, LLC, a limited liability company organized under the laws of the State of Delaware ("Grantor"), granted security interests in and liens upon (the "Security Interests") certain patents and trademarks in favor of Rodney Aboff, Christopher Cagnazzi, Mitchell Conn, Jack DiMaio, Daniel Goldman, Harry Lerner, Stephen Lerner, Vincent Luciano, Thomas Prunty, and VL Group, LLC (collectively the "Secured Parties"), as set forth in those certain Confirmatory Security Agreements recorded with the United States Patent and Trademark Office on April 22, 2010 at Reel/Frame 024273/0477, and on May 5, 2010 at Reel/Frame 4204/0202, (the "Security Agreements") pursuant to that certain Loan Amendment and Exchange Agreement between the Grantor and Secured Parties;

WHEREAS, pursuant to section 8.12 of that Loan Amendment and Exchange Agreement, upon the occurrence and completion of the Second Tranche Closing, the Security Interests, including in and to the patents and trademarks listed on Schedule A hereto, shall *ipso facto* be terminated;

WHEREAS, the Second Tranche Closing has occurred and completed; and

WHEREAS, pursuant to section 8.12 of that Loan Amendment and Exchange Agreement, the Secured Parties authorize counsel for Grantor, namely Mintz, Levin, Cohn, Ferris, Glovsky and Popeo, P.C. ("Mintz") to file any and all terminations and discharges as may be reasonably necessary or appropriate to reflect the termination of the Security Interests.

NOW, THEREFORE, pursuant to the terms of that Loan Amendment and Exchange Agreement, and the occurrence and completion of the Second Tranche Closing :

1. Mintz, on behalf of and as authorized by the Secured Parties, hereby terminates the Security Agreements and terminates, releases, and discharges any and all security interests that the Secured Parties have in any and all right, title and interest that the Secured Parties may have, in, to and under the patents and trademarks listed on Schedule A hereto, and hereby reassigns, grants and conveys to the Grantor any and all such right, title and interest in such patents and trademarks, including any and all goodwill associated therewith, free and clear of all such Security Interests.

2. The Secured Parties authorize and request that the Commissioner for Patents and Trademarks and any other applicable government officer record this release.

IN WITNESS WHEREOF, the Secured Parties have caused this Confirmatory Termination of Intellectual Property Security Agreements to be executed by counsel for the Grantor as of the date above first written.
