TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (the “Release”) is made this 17th day of August, 2021 (the “Release Date”) by Hercules Capital, Inc., a Maryland corporation, as Agent (in such capacity, the “Agent”), for the benefit of Envisage Technologies, LLC, a Delaware limited liability company, and Guardian Tracking, LLC, an Indiana limited liability company (the “Debtors”).

WHEREAS, (i) Envisage Technologies, LLC has entered into that certain Intellectual Property Security Agreement, dated as of March 19, 2020 with Agent (as at any time prior to the date hereof amended, supplemented or otherwise modified, the “Envisage Security Agreement”), and recorded with the U.S. Patent and Trademark Office (“USPTO”) at Reel/Frame No. 6895/0628 and (ii) Guardian Tracking, LLC has entered into that certain Intellectual Property Security Agreement, dated March 15, 2021 with Agent (as at any time prior to the date hereof amended, supplemented or otherwise modified, the “Guardian Security Agreement”, and together with the Envisage Security Agreement, the “Security Agreements”), and recorded with the USPTO at Reel/Frame No. 7233/0228, pursuant to which the Debtors granted to Agent security interests and liens in and to certain assets of the Debtors, including, without limitation, all trademarks, service marks, trade names, trade dress, Internet domain names or other indicia of trade origin, whether registered or unregistered, trademark and service mark registrations, and applications for trademark or service mark registrations and any renewals thereof, including, without limitation, each registration and application identified in Exhibit A attached hereto and made a part hereof, and including, without limitation, (i) the right to sue or otherwise recover for any and all past, present and future infringements and misappropriations thereof, (ii) all income, royalties, damages and other payments now and hereafter due and/or payable with respect thereto (including, without limitation, payments under all licenses entered into in connection therewith, and damages and payments for past, present or future infringements thereof), and (iii) all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of the Debtors accruing thereunder or pertaining thereto, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such trademark, service mark, trade name, trade dress, Internet domain name or other indicia of trade origin (the “Intellectual Property Collateral”); and

WHEREAS, all outstanding amounts owed under any financing documents executed in connection with the Security Agreement have been satisfied and the Debtors have requested that the Agent release its security interest in the Intellectual Property Collateral.

NOW THEREFORE, in consideration thereof and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent agrees as follows:

1. Release of Security Interest. Effective as of the Release Date, the Agent hereby forever terminates, releases and discharges any and all security interests in the Intellectual Property Collateral granted by the Debtors under the Security Agreement, together in each case with the goodwill of the business connected with the use of, and symbolized by, each such Mark.

2. Recordation of Release. The Agent understands and agrees that this Release may be recorded by or for the Debtors with the USPTO.

3. Further Actions. The Agent further agrees to execute any other documents and take any further action reasonably necessary in any state, country or jurisdiction that the Debtors may reasonably require to effect the intent and purpose of this Release, provided that all such documents are to be prepared by counsel to the Debtors and the cost and expense of such documents and actions shall be borne solely by the Debtors.

4. Capitalized Terms. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the Security Agreement, as applicable.


