**NOTICE OF RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS**

This NOTICE OF RELEASE OF SECURITY INTEREST IN U.S. TRADEMARKS (as amended, restated, supplemented or otherwise modified, this “Notice of Release”), effective as of August 17, 2021, is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, as Administrative Agent (the “Administrative Agent”).

NOW, THEREFORE, for valuable consideration, the Administrative Agent hereby discharges and releases all mortgages, liens and security interests granted to the Administrative Agent in the Specified Trademark Collateral and all related proceeds, products, rents and profits of or from the foregoing Specified Trademark Collateral, including without limitation any claim by the Administrative Agent against third parties for past, present, or future infringement or dilution of the Specified Trademark Collateral and injury to the goodwill associated with the Specified Trademark Collateral; provided, however, that no other mortgages, liens or security interests are released hereby except as expressly set forth herein, and the Trademark Notices shall remain in full force and effect with respect to all trademarks, trademark applications and all related proceeds, products, rents, profits and claims with respect thereto, other than the Specified Trademark Collateral.

The Administrative Agent hereby authorizes Grantor to file and record this Notice of Release of Security Interest in U.S. Trademarks with the United States Patent and Trademark Office.


