TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Termination and Release"), dated as of August 2, 2021, by Wells Fargo Bank, National Association, in its capacity as collateral agent pursuant to the Revolving Credit Agreement (in such capacity, the "Collateral Agent").

WITNESSETH:

WHEREAS, pursuant to certain Trademark Security Agreements recorded with the Trademark Division of the United States Patent and Trademark Office on July 25, 2016 and February 28, 2018, at Reel/Frame 5842/0435 and Reel/Frame 6281/0219 (the "Trademark Security Agreements"), a lien on and security interest (the "Security Interest") was granted by JM Swank, LLC and Lentz Milling Company, LLC (collectively, the "Grantors") to the Collateral Agent in certain collateral, including but not limited to the trademarks set forth on Schedule 1 hereto (the "Trademarks");

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby agrees as follows:

1. Definitions. Capitalized terms not defined herein shall have the meanings set forth in the Trademark Security Agreements.

2. Release of Security Interest. The Collateral Agent, without representation, warranty or recourse, hereby absolutely, unconditionally, irrevocably and forever terminates the Trademark Security Agreements and terminates, releases, cancels and discharges any and all Security Interests in (collectively, the "Trademark Collateral");

(a) the Trademarks (as defined in the applicable Trademark Security Agreement) of such Grantor listed on Schedule I attached thereto;

(b) all Goodwill (as defined in the applicable Trademark Security Agreement) associated with such Trademarks; and

(c) all Proceeds of any and all of the foregoing, and

any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void.

3. Recordation. The Collateral Agent authorizes each Grantor and its designees to record this Termination and Release with the United States Patent and Trademark Office or any other applicable governmental authority at such Grantor's expense. The Collateral Agent further authorizes and requests that the Commissioner of Trademarks and any other applicable government officer record this Release.
