DOMAIN NAME AND TRADEMARK ASSIGNMENT

THIS DOMAIN NAME AND TRADENAME ASSIGNMENT (this "Assignment") is made this 1st day of June 2021 ("the "Effective Date"), by and between 7 Lakes Ranch, LLC, a Colorado limited liability company ("Assignee"), and Great White Shark Enterprises Inc., a Florida corporation ("Great White") and Greg Norman Interactive L.L.C., a Florida limited liability company ("GNI" and together with Great White, collectively the "Assignor").

RECITALS

A. Seven Lakes Lodge, LLC, a Colorado limited liability company, Pollard Ranch, LLC, a Colorado limited liability company, and DC RANCH LLC, a Colorado limited liability company (collectively, "Sellers") and Assignee entered into a Contract to Buy and Sell Real Estate (Land) dated December 08, 2020, and that certain COUNTERPROPOSAL dated December 15, 2020, together with an ASSIGNMENT AND AMENDMENT TO CONTRACT TO BUY AND SELL REAL ESTATE (LAND), dated May 21, 2021 (collectively, the "Contract"), whereby Assignee acquired certain real estate in Rio Blanco County, Colorado, known generally as Seven Lakes Lodge (the "Real Estate").

B. Assignor and Sellers are affiliated entities. Great White is the owner of the Trademark and Trademark Rights (all as defined below), and GNI is the owner of the Website, Domain Name, Email Address and the Domain Name and Related Rights (all as defined below). In connection with the Contract, and as an accommodation to the Sellers, each Assignor has agreed to assign its respective rights to Assignee and Assignee has agreed to assume all of each Assignor's right, title and interest in and to (i) the domain name "SevenLakesLodge.com" (sometimes referred to as the "Website" or "Domain Name"), (ii) email permissions related to @sevenlakeslodge.com (sometimes referred to as the "Email Address"), and (iii) trademarks related to "7Lakes" (the "Trademark"), as set forth on Schedule B attached hereto and hereby incorporated into this Assignment and to execute this Assignment to enable Assignee to record the assignment of all of each Assignor's right, title and interest in and to the Domain Name registered with the domain name registrar (the "Registrar"), as set forth on Schedule A attached hereto and hereby incorporated into this Assignment, the associated registration and renewals, all goodwill associated

6. Successors and Assigns. This Assignment shall be binding upon each party hereto and its respective successors and assigns.

7. Governing Law. The parties specifically agree that this Assignment shall in all respects be interpreted, read construed and governed by the internal laws of the State of Colorado, exclusive of its conflicts of law rules.

8. Counterparts. This Assignment may be executed simultaneously in any number of counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. The parties to this Assignment may deliver their executed counterparts by facsimile or other electronic means.

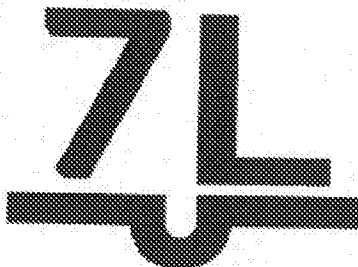
