**TRADEMARK ASSIGNMENT AGREEMENT**

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee agree as follows:

1. Assignor hereby irrevocably assigns, sells, conveys and transfers to Assignee all right, title and interest in and to the Marks; (ii) the goodwill of the business symbolized by and associated with the Marks, and business conducted under the Marks, including but not limited to the goodwill of the business relating to the goods and services that the Marks are used in connection with, and any part thereof, such assignment includes the portion of the business of Assignor to which the Marks pertain; (iii) all common law and statutory rights in the Marks, specifically including the Registration, any and all renewals thereof, and the benefits resulting therefrom, and all other related intellectual property and rights; (iv) the Applications for registration of the Marks, including the right to prosecute the Applications and any additional applications for the Marks and enjoy the benefits of any registration resulting therefrom; (v) income, royalties, damages and payments hereafter due or payable to Assignor with respect to the Marks, including but not limited to the right to sue (including filing and prosecuting opposition, cancellation and similar proceedings) and recover for, and the right to profits or damages due or accrued, arising out of or in connection with, any and all past, present or future infringements, unfair competition, unjust enrichment or dilution of or damage or injury to or based on said Mark or such associated goodwill; and (vi) the right to defend the Mark, the Application and the Registration.

2. Assignor hereby requests that all appropriate trademark offices issue registration for the Application in the name of Assignee.

3. Assignor hereby authorizes and requests the United States Patents and Trademark Office and any other intellectual property offices throughout the world to record this

Assignment Agreement and record Assignee as the owner of the Applications and/or Registrations.

4. Assignee declares that it is engaged in activities compatible with the goods/services claimed by the Application and/or Registrations. Assignee and Assignor declare that its authorized signatories are vested in powers to represent them in this Assignment Agreement.

5. This Assignment shall be binding upon and inure to the benefit of the parties hereto and their respective successors and assigns.
