RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (“Release”) is made as of this 20th day of August, 2021, by REGIONS BANK, as the Administrative Agent and Collateral Agent (“Administrative Agent”), in favor of United WELD Holdings LP, a Delaware limited partnership (the “Grantor”).

NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Administrative Agent hereby discharges, terminates and releases the IP Security Agreements and all liens and security interests in all right, title and interest in, to or under any and all of the trademarks and trademark applications listed on Schedule 1 thereto and granted by Grantor in favor of Administrative Agent. Administrative Agent hereby transfers and assigns to the Grantor any and all right, title and interest that Administrative Agent may have obtained in, to or under the trademarks and trademark applications listed on Schedule 1 of the IP Security Agreements.
