**RELEASE OF SECURITY INTEREST
IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (this “**Release**”), dated as of August 20, 2021, is made by **ELM PARK CAPITAL MANAGEMENT, LLC**, as administrative agent (in such capacity, together with its successors and permitted assigns (the “**Agent**” and “**Releasor**”) for the Lenders and each other Secured Party as defined in the Credit Agreement referred to below. Terms used in this Release and not herein defined shall have the meanings set forth in the Trademark Security Agreement, as defined below.

WHEREAS, the Borrowers, Holdings, the Lenders, and Agent are party to the Senior Subordinated Credit Agreement dated May 11, 2018 (as may be amended, restated, supplemented and/or modified, the “**Credit Agreement**”).

WHEREAS, in connection with the Credit Agreement, **ACCESSONE MEDCARD, INC.**, (“**Releasee**”) and Releasor entered into the Trademark Security Agreement, dated May 11, 2018, that was recorded with the United States Patent and Trademark Office on May 14, 2018, at Reel 6330, Frame 0054 (“**Trademark Security Agreement**”), granting a security interest in the Trademarks owned by Releasee, including those items listed on Annex I attached hereto (collectively, the “**Trademark Collateral**”).


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, on behalf of itself and each other Lender and Secured Party, hereby **RELEASES**, terminates and discharges its liens and security interests in and to the Trademark Collateral and all goodwill associated therewith, and all other right, title and interest in and to the Trademark Collateral, and reassigns to the Releasee any and all such right, title and interest that it may have in the Trademark Collateral and the associated goodwill, without recourse or representation or warranty, express or implied, of any kind. The Agent agrees to execute, acknowledge, procure and deliver to the Releasee any and all further documents or instruments and do any and all further acts which the Releasee (or its respective agents, designees or assignees) reasonably requests in order to confirm, effectuate or record this Release and the Releasee’s (or its assignees’) right, title and interest in and to the Trademark Collateral.

The Agent agrees, at the Releasee’s expense, to cooperate with the Releasee and to provide the Releasee with the information and additional authorization reasonably required or desirable to effect the release of the security interest in the released collateral described herein.
