**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This Release of Security Interest in Trademarks (this "Release") is intended to operate as a release of all liens and security interests conveyed by Company to Agent in the Trademark Collateral pursuant to the terms of the Trademark Security Agreement, and to reassign to Company all of Agent's right, title, and interest acquired in the Trademark Collateral pursuant to the terms of such Trademark Security Agreement, in each case without any representation, warranty, recourse or undertaking by Agent.
