Pursuant to 805 Ill. Comp. Stat. §5/11.39 of the Illinois Business Corporation Act of 1983 and 6 Del. C. §18-209 of the Delaware Limited Liability Company Act, the undersigned limited liability company executed the following Certificate of Merger:

FIRST: The surviving entity will be a Delaware limited liability company named **Elastocon TPE Technologies, LLC**, and the company being merged into this surviving limited liability company is an Illinois corporation, for which an S-election has been made under 26 USCS §1362(a), named **Elastocon TPE Technologies Incorporated**.
