**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Trademark Release”) is made as of August 18, 2021, by **DEUTSCHE BANK AG NEW YORK BRANCH** (“Collateral Agent”) in favor of **CRYOLIFE, INC.**, a Florida corporation with an address at 1655 Roberts Blvd., NW, Kennesaw, GA 30144 (the “Grantor”).

WITNESSETH:

WHEREAS, the Grantor entered into a certain trademark security agreement dated December 1, 2017 (the “Trademark Security Agreement”) with Collateral Agent, notice of which was recorded on December 5, 2017 at the United States Patent and Trademark Office at Reel 6221, Frame 0636.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Collateral Agent, under the terms of the Trademark Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Collateral Agent, in and to all of such Grantor’s right, title and interest in the Trademark Collateral, including without limitation the Trademarks listed in Schedule A.

WHEREAS, the Collateral Agent has agreed to terminate and release its Security Interest in all such Trademark Collateral as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent hereby releases, terminates and discharges the Security Interest in the Trademark Collateral of the Grantor, and assigns, transfers and conveys to Grantor such Security Interest in such intellectual property.
