## TERMINATION OF SECURITY INTEREST IN TRADEMARK

**WHEREAS**, the Secured Party desires to release its security interest in only the Trademark, as listed in Schedule A;


**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Secured Party does hereby:
