## ASSIGNMENT OF TRADEMARKS

### RECITALS

This assignment of trademarks (“Agreement”) is made, entered into, and effective as of this 23<sup>rd</sup> day of August 2021 between Instantgo, Inc., a Delaware corporation with a principal place of business located at 1173 Rodeo Drive, Los Angeles, CA 90035 (“Assignor”), on the one hand, and Space Corporation, a California corporation with a principal place of business at 5628 W Washington Boulevard, Los Angeles, CA 90016, on the other hand (“Assignee” and jointly, the “Parties”).

**WHEREAS**, Assignee desires to acquire the Assigned Rights and accompanying goodwill from Assignor, and Assignor desires to assign said rights to Assignee;



Such rights shall include without limitation all intellectual property rights, moral rights and goodwill therein and thereto, and the right to bring, make, oppose, defend, and appeal proceedings, claims or actions and obtain relief (and to retain any damages recovered) in respect of any infringement, or any other cause of action (including passing off) arising from ownership, of the Assigned Rights whether occurring before, on, or after the date of this Agreement.
