TERMINATION AND RELEASE OF  
GRANT OF SECURITY INTEREST IN TRADEMARKS

THIS TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARKS (this "Termination"), is dated as of August 24, 2021, and made by TC Lending, LLC, as the collateral agent, having an office at 888 Seventh Avenue, 35th Floor, New York, NY 10106 (the "Collateral Agent") to ServiceChannel.com, Inc., a Delaware corporation (the "Grantor"). Unless otherwise defined herein, capitalized terms used herein shall have the same meanings ascribed to them in the Security Agreement (as defined below).

WHEREAS, the Grantor, certain other parties thereunder, and the Collateral Agent entered into that certain Pledge and Security Agreement dated as of June 3, 2020 (as amended, restated, supplemented, modified or otherwise changed from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantor executed and delivered to the Collateral Agent that certain Grant of a Security Interest -- Trademarks dated as of June 3, 2020 and recorded with the United States Patent and Trademark Office on June 3, 2020, at Reel 6952 and Frame 0437 (the "Trademark Security Agreement"), pursuant to which the Grantor granted to the Collateral Agent for the benefit of the Secured Parties a continuing security interest in the Collateral (as defined in the Trademark Security Agreement); and

WHEREAS, the Collateral Agent now desires to terminate and release the security interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent hereby terminates, releases and discharges its security interest in the Collateral, and hereby reassigns to each Grantor, as applicable, any right, title, or interest it may have in the Collateral of such Grantor, without recourse or representation or warranty, express or implied, of any kind.
