NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby (i) releases and discharges any and all liens on, and its security interest in and to the Collateral, including the Trademarks (or applications) set forth on Schedule A, attached hereto, and (ii) authorizes the recordation of this Release by Grantor or its designee with the United States Patent and Trademark Office.

This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.


