Assignor covenants and agrees that Assignor shall, at the request of Assignee or its counsel, execute, acknowledge and deliver all such further acts, deeds, assignments, transfers, powers of attorney and assurances as may be required to carry out the intent of this Assignment.

This Assignment shall be binding upon and shall inure to the benefit of Assignor and Assignee and their respective successors, legal representatives and assigns, and all others acting by, through, with or under the Assignor's direction and all those in privity therewith.

This Assignment shall be governed by, and construed in accordance with (i) the laws of Quebec and the laws of Canada applicable therein in respect to trademark and copyright issues; and (ii) in all other respects, including as to validity (except for copyright and trademark issues), interpretation and effect, by the laws of the Province of Quebec.

The parties hereto state their express wish that this Agreement as well as all documentation contemplated thereby, pertaining thereto or to be executed in connection therewith be drawn up in the English language; les parties expriment leur désir explicite à l'effet que cette offre et la convention de même que tous documents envisagés par les présentes ou y ayant trait ou qui seront signés relativement aux présentes soient rédigés en anglais.


