## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of August 25, 2021, is made by Wells Fargo Bank, National Association (together with its successors and assigns, the "Lender"), for itself and for the Secured Parties (in such capacities, the "Grantee") in favor of The Golf Warehouse, LLC, a Minnesota limited liability company, formerly known as The Golf Warehouse, Inc., a Delaware corporation ("Grantor");

WHEREAS, pursuant to that certain Pledge and Security Agreement dated as of April 10, 2015 (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement") by and among the Grantor, Grantee, and others party thereto, and that certain Confirmatory Grant of Security Interest in United States Trademarks effective as of April 10, 2015 (the "Trademark Agreement"; all capitalized terms not defined herein shall have the respective meaning given to them in the Security Agreement or Trademark Agreement, as applicable) by and among the Grantor and Grantee, Grantor pledged and granted to Grantee, on behalf of and for the benefit of the Secured Parties, a security interest in all of Grantor's right, title and interest in and to (a) its trademarks (including service marks), trade names, trade styles, trade dress and the registrations and applications for registration thereof, including the trademarks listed on Exhibit A attached hereto and the goodwill of the business symbolized by the foregoing (the "Marks"); (b) all licenses of the foregoing, whether as licensee or licensor; (c) all renewals of the foregoing; (d) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future infringements thereof; and (e) all rights to sue for past, present, and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing (clauses (a) through (e) collectively being the "Trademark Collateral"), and such Trademark Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on May 13, 2015 at Reel 5514, Frame 0956;


